Code Enforcement Fee Schedule

Residential Building Permits

- A. Roofing permits shall be \$45.00
- B. Alteration/Addition/Remodel permits shall be \$75.00
- C. New Residential construction permits shall be \$400.00
- D. Residential Accessory Structure permits shall be \$35.00
- E. Fence permits shall be \$20.00

Non-Residential Building Permits

B101 Total Valuation	Fee
Section (1) \$1,000 and less	\$25.00
Section (2) \$1,001 to \$50,000	\$25.00 for the first \$1,000 plus \$5.00 for each additional \$1,000.
Section (3) \$50,001 to \$100,000	\$160.00 for the first \$50,000 plus \$4.00 for each additional \$1,000.
Section (4) \$100,001 to \$500,000	\$260.00 for the first \$100,000 plus \$3.00 for each additional \$1,000.
Section (5) \$500,001 and up	\$860.00 for the first \$500,000 plus \$2.00 for each additional \$1,000.

B102 Penalties

Where work for which a permit is required by code is started or proceeded prior to obtaining said permit, the fees herein specified shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of the code in the execution of the work nor from any other penalties.

B103 Plan Review fees

When a plan review is required to be submitted, a plan review fee shall be paid at the time of submitting plans and specifications for review. Said plan review fee shall be equal to the building permit fee. Such plan review fee is in addition to the building permit fee.

B104

Inspection fees shall be \$25.00 for each inspection.

B105

Moving permit fee shall read - For the moving of any building or structures, the fee shall be \$50.00.

B106

Demolition permit fee shall read – For the demolition of any building or structures, the fee shall be \$50.00.

B107

Building contractor license fee shall be \$35.00 annually.

B108

Contractors bond shall be a minimum of \$20,000.00 or \$300,000 minimum General Liability Policy.

B109

Certificate of Occupancy inspection fee shall be \$75.00.

B110

Curb/Street cut permit fee shall be \$30.00.

B111

Fire Protection permit fee shall be \$80.00.

Residential Mechanical Permits

- A. Alteration/Addition/Remodel permits shall be \$55.00
- B. New Residential construction permits shall be \$75.00

Mechanical contractor registration fee shall be \$35.00 annually.
